PRIVACY POLICY - DATA PROTECTION INFORMATION

In accordance with Regulation (UE) n. 2016/679 (hereafter also referred to as "**GDPR**") and Italian laws (in particular d.lgs. n. 196/2003 and subsequent amendments), we inform you how we process your personal data.

1. Data Controller

Fabbrica Dallara S.r.l., with its register office in (43040) Varano de' Melegari, via Marconi n. 18 (PR), Italy, e-mail: <u>privacy@dallara.it</u> (hereafter also referred to as "**Data Controller**").

2. The categories of data that we process

Personal data

Relevant personal data categories may in particular be (hereafter also referred to as "**Data**"):

<u>personal identification data</u> (name, date of birth, place of birth, nationality, contact person and/or similar data); <u>contact data</u> (address, administrative address, telephone number, e-mail address and/or comparable data and all the information useful to enter into relationship with you and your organization/collaborators); <u>vehicle identification numbers and/or maintenance and repair information relative</u> <u>to vehicle</u>.

The Data will be processed by trained staff, and communicated only to designated employees for the purposes described above.

The Data will only be collected, processed and/or used if you provide us with it voluntarily in order to use the services and contents (including the Technical Information) on the website <u>https://dpn.dallara.it/</u> in accordance to "GENERAL TERMS AND CONDITIONS OF REGISTRATION AND USE THE DALLARA STRADALE PORTAL NETWORK AND THE DALLARA STRADALE DIAGNOSTIC EQUIPMENT". If it is necessary to pass the Data on to third parties, for example to collect the purchase price per credit card, the Data will be transmitted to these third parties.

Navigation data

The computer systems and the software procedures used for the functioning of this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. It deals with information which is not collected to be associated to interested identified parties, but which by their very nature may, through elaborations and associations with data held by third parties, allow to identify users. This category of data includes IP addresses or names retained by computer used by users who connect to a website, URI addresses (Uniform Resource Identifier) of resources requested, the time of request, the method used to submit the request to the server, the file size obtained in response, the numerical code indication the status of the response given by the server (successful, error, etc.) and other parameters concerning the operating system and the user's computer environment. These data are used only



to obtain anonymous statistical information on the use of the website and to check its correct functioning.

Legal defense: your personal data may be used for the defense by the Data Controller in court or in the stages leading to legal action, against improper use of the same or related services by you. The data may be handled to ascertain responsibility in case of hypothetic computer crimes against the site.

Maintenance: your personal data may be handled with additional methods and objectives related to the maintenance of the systems.

3. Purpose of data processing

The Data Controller processes the Data for the correct management of the existing business and service relationship in accordance to "GENERAL TERMS AND CONDITIONS OF REGISTRATION AND USE THE DALLARA STRADALE PORTAL NETWORK AND THE DALLARA STRADALE DIAGNOSTIC EQUIPMENT".

In particular, the Data voluntarily provided will be used for the following purposes, unless otherwise notified:

- to surf the current website and have your specific account;

- for sending information required by you;

- to access/use/purchase the services and the contents (including the Technical Information) on the website;

- for administrative-accounting activities in general (for the correct management of the existing business and service relationship in accordance to "GENERAL TERMS AND CONDITIONS OF REGISTRATION AND USE THE DALLARA STRADALE PORTAL NETWORK AND THE DALLARA STRADALE DIAGNOSTIC EQUIPMENT"). For the application of the provisions regarding the personal data the processing carried out for administrative-accounting purposes are those related to the performance of organizational, administrative, financial and accounting-type activities, regardless of the nature of the data processed. In particular, the internal organizational activities pursue these purposes, those functional to the fulfilment of contractual and pre-contractual obligations, information activities.

4. Nature of conferment

Apart from what specified for navigation data, the provision of Data is mandatory for the implementation of the existent relationship. The refusal to provide Data implies the impossibility for the Data Controller to proceed with the establishment of the relationship and its timely execution.

In fact, you only need to provide Data that is necessary for the commencement and performance of the business relationship or for a pre-contractual relationship with us or the collection of which we are required by law. Without these data, Data Controller is generally not able to conclude the agreement or continue to perform

5. Rights of the person concerned

You may exercise the rights expressed in article 15 and seq. of Regulation (UE) 2016/679, by contacting the Data Controller. For example, you have the right to obtain information on the following: a) the confirmation of the existence or not of Data and their origin; b) the handling purposes and methods; c) the updating correction or, when it occurs, the integration of data. You can always ask for complete specification of the processing and your rights by writing to the contacts made available by the Data Controller and indicated at the beginning of this information.

If you believe that the Data processing breaks the Regulation (UE) 2016/679 Regulation, you have the right to lodge a complaint with a supervisory authority, the Data Protection Authority.

6. Methods of data processing

Data handling is performed by using computer procedures or other electronic means or printed material handled by internal or external personnel specially assigned for this purpose and pledged to confidentiality. The Data are stored in electronic files with the complete assurance of security measures laid down by the legislature.

7. Communication and dissemination

The Data collected shall not be subject to disclosure or dissemination.

Within the company of Data Controller, the Data collected may be disclosed to the affiliated entities of company and/or the company employees/collaborators in charge of the processing of personal data designated by Data Controller.

8. How long the Data is kept

We will keep the Data for the entire duration of the business relationship and, in particular, for a period deemed strictly necessary to fulfil such purpose. Therefore, we will store and process the Data until the business relationship will be terminated or until you will request cancellation from this website (<u>https://dpn.dallara.it/</u>), however the Data may still be kept for fulfilling tax or financial obligations or other obligations required by laws.

9. Changes to Privacy Statement

The Data Controller reserves the right to modify, update, add or remove parts of the current Privacy Policy at his discretion and at any time. The person concerned has to check periodically for any changes. In order to facilitate such verification, the information notice will contain the date of updating of our privacy practice. The use of the website, after the posting of changes, will constitute your agreement of the same.

COOKIES POLICY

The application software may contain "cookies" technology. Cookies are primarily used to facilitate user navigation.
